It is understood that the parking of vehicles shall not block any driveways, access to public water sites or ingress or egress to other village properties. All village and state codes including parking on public highways shall be complied with.

\_\_\_\_ Valid and current copy of any permits or certificates which may be required by any enforcement agency such as the NYS Dept. of Health for mobile food vehicles.

\_\_\_\_ Certificate of Liability Insurance identifying the Village of Speculator, NY as an additional insured, which will protect the vendor and the Village from all third party claims for damage to property or person, including death which may arise from the operations under the permit or in connections therewith. Such insurance shall provide coverage of not less than \$1,000,000/occurrence (\$5,000,000 if any lake access is involved). Such policy cannot be cancelled without at least 30 days prior written notice to the Village.

By signing below, the applicant certifies that he/she is the principal applicant for a temporary vendor permit application in the Village of Speculator, NY for the purpose as listed above. Applicant and any other persons associated with the execution of this permit agrees to indemnify and hold the Village harmless from and against any claims, demands, lawsuit, settlements, damages, cost and expenses, including attorneys' fees, suffered or incurred by the Village and arising out of or in connection with the revocable temporary license application.
